Caroline Willburn from Wigan, Wrightington, Wigan and Leigh NHS Foundation Trust (WWL) has volunteered to be the lead for this group. Caroline has been an ICS operator for 24 years. Held a meeting with Elmarie Cairns, ICS lead for SW as they have a very well-established setup / network.

Intend to get support for a region wide minimum data set which is the minimum data set we are hoping to present through the NBTC for national consideration. Looking to set up regional educational days and having WWL, Salford plus other NCA hospitals as an initial setup of groups.

7 RTC Budget

Credits

RH mentioned how several hospitals are not claiming credits for blood components e.g. FFP that is split while thawing, unused AB or split red cell in a delivery.

Emergency Contingency Planning for Blood

JP has received comms encouraging “buddy system” with major trauma centres. Recommending:

- Salford Royal Hospital “buddy up” Royal Manchester Children’s Hospital
